- They are mellow and good humored
- They always see person behind the illness.
- They are motivated by yesterday and to day not tomorrow.
- They are patient (or at least, they keep their impatience to an imperceptible slow burn)
- They are seemingly unflapple

2008 circle of Care stated that qualities of caregiver are as follows:

- Allow the warmth and compassion in your heart to touch your care recipient's heart.
- Practice the simple basics of treating one with the same respect, esteem and care with which you would want to be treated if the role were reversed and you were the care recipient.
- Express kindness when speaking with care recipient.
- Use authentic and positive words to acknowledge and appreciate.
- Use strength-based communication stating what works in a place of using words or tones that are harsh, irritable and negative.

- Treat your care client as if they are their own unique and special person, not as a case, patient, project, or burden.
- Encourage a client to share their strength talent and skills by enlisting their participation expertise and help with daily activities.
- Use tender and gentle touch when caring for your client, but always first check-in, inform and ask permission, offer a gentle hand or foot message and make time for tenderness and affection. Beware of client likes and dislikes regarding any kind of physical touch, and using too much force especially if there is pain or sensitive involved. Ryder (1985) cited by Kadiri Journal of Education Research and Policies Vol. 4. Numbers 2009 identifies the following characteristic of the caregiver:
- Transmit positive feelings about themselves and their job.
- Spend most of their time interacting with or observation children.
- Are familiar with the various stages of children's growth and encourage each child's development.
- Attend to children needs, are calm and gentle
- Demonstrate flexibility and a sense of humor
- Are fair when squabbles occur
- Believe in discipline but not in harsh punishment
- Encourage healthy curiosity.

The care of the child is fundamental with the hands of a caregiver.

# **Need for the Training of Caregiver**

provide a global platform for policy dialogue to provide a global plat form for policy dialogue and to promote exchange of good practices in ECCE policy for sustainable development and implementation. A progress was made towards the EFA Goal 1 in ECCE as a social, human and economic development imperative. We adopt a broad and holistic concept of ECCE as the provision of care, education aged zero to eight years of age. ECCE is therefore for a right of an indispensable foundation for life long learning. Its proven benefits are manifold and include health and nutrition, improved emotional efficiency and gender equity, greater employability and earning, and better quality of life for sustainable development. The evidence of the benefits of ECCE and its capacity to pay it self back was recently review in the EFA Global Monitoring Report (UNESCO 2006).
